

CONTEST RULES

Share our Screens to Meet Dr. David Suzuki
Luminato Festival Toronto

1. **ELIGIBILITY** – This contest is only open to residents of Ontario who are over the age of majority and are not employees of Luminato (herein referred to as the “Contest Sponsor”), its parent and affiliated companies, representatives, dealers and agents, Contest suppliers and judges, or domiciled with any such employee.
2. **CONTEST PERIOD** – The Contest starts at midnight on May 25, 2022 and continues until 11:59pm on June 6th, 2022 the “Contest Closing Date”. No purchase necessary. All times are Eastern Standard Time.
3. **TO ENTER the Contest** -
Share the contest asset to your Instagram story, tagging @luminatofestival and tag friends in the comments. Each tag is an entry. All entrants are subject to the terms and conditions associated with creating and maintaining an Instagram account as well as the Instagram privacy policy, which is at the sole discretion of Instagram and can be found at <https://help.instagram.com/581066165581870>

5. Any attempt or suspected attempt to use robotic, automatic, programmed or any entry methods not authorized by these rules, shall be deemed as tampering and will void all of your entries. All entries that are incomplete, illegible, damaged, contain an erroneous phone and/or email address or do not conform to or satisfy any condition of the rules may be disqualified by the Contest Sponsor.

The draw and selection will be announced via Luminato's Instagram story and once the winner is confirmed, Luminato will announce the winner via Luminato's Instagram story.

If the selected entrant cannot be reached **within one (1) business day** following the first attempt of contact, declines the prize, or fails to provide the proof of vaccination as specified above, the Contest Sponsor reserves the right, at its sole discretion, to select another entrant via random draw from all remaining eligible entries or to cancel the prize.
